RESOLUTION NO. 97-380

WHEREAS, the Tohono O'odham Legislative Council authorized the creation of a general Scholarship Program and a specialized Nursing Home Scholarship Program; and

WHEREAS, the Tohono O'odham Nation requires specialized legal services to review the existing structures of the general and Nursing Home Scholarship Programs for compliance with applicable laws; and

WHEREAS, adequate funds are presently available in the Scholarship Program Fund to support this contract amount; and

WHEREAS, the Tohono O'odham Legislative Council did this day review the bidding documents and proposed contract and does hereby concur with the recommendation of the reviewing Committees and the Chairman of the Nation.

NOW, THEREFORE, BE IT RESOLVED that:

- 1. The attached Attorney Contract with Ms. Freund is approved and the Executive is authorized to execute this contract; the term of this contract is September 15, 1997 through December 31, 1997.**
- 2. The Executive is authorized to expend funds as required and pursuant to this contract from the Scholarship Program.**
