WHEREAS, the fiscal year ends at midnight, September 30, 1997 and all spending authority granted under the FY 1997 budget ends at that time; and

WHEREAS, the continued operation of the Judicial Branch of the Tohono O'odham Nation requires adoption of an operating budget, the grant of spending authority and the appropriation of funds for FY 1998; and

WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget that reflects the needs of the Branch, said budget is attached hereto and incorporated by reference; and

WHEREAS, the Budget and Finance Committee of the Legislative Council of the Tohono O'odham Nation has reviewed this budget and recommends its approval and adoption.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council of the Tohono O'odham Nation that it hereby approves the FY 1998 budget submitted by the Judicial Branch.

BE IT FURTHER RESOLVED that funds in the amount of \$4,916,506., are appropriated and authorized to be expended from sources of funding approved by this Council for support of the FY 1998 budgets of the Tohono O'odham Nation.


