1 2 3 RESOLUTION NO. 97-392 4 the Office of the Chairman of the Tohono O'odham Nation WHEREAS. 5 submitted for review and approval their FY 1998 budget to the 6 Tohono O'odham Legislative Council; and 7 8 WHEREAS, the proposed budget includes a 5% adjustment to the FY 1997 9 salary positions for the Chairman and Vice Chairman of the 10 Tohono O'odham Nation: and 11 WHEREAS. a recommendation was made for an 18% cost of living 12 13 adjustment to the salaries of the Nation's Chairman and Vice 14 Chairman for FY 1998. 15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative 16 Council hereby approves an 18% cost of living adjustment to 17 the salaries of the Tohono O'odham Nation's Chairman and 18 19 Vice Chairman for FY 1998. 20 BE IT FINALLY RESOLVED that the total adjusted salaries for the Chairman 21 of the Nation is from \$44,007.00 to \$51,928.26 and for the 22 Nation's Vice Chairman from \$37,022.00 to \$43,685.96. 23 24 The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH, day of SEPTEMBER, 1997 at a meeting at which a quorum was present 25 with a vote of <u>1,257.0</u> FOR; <u>114.0</u> AGAINST; <u>556.0</u> NOT VOTING; and <u>[06]</u> ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the **27** Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,

pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
