**RESOLUTION NO. 97-395**

**WHEREAS, the Executive Branch has prepared and presented its fiscal  
year 1998 Base Budget to the Tohono O'odham Legislative  
Council; and**

**WHEREAS, the Executive Branch FY 98 Base Budget funds regular  
department and program operations, and has been prepared  
to reflect the market and longevity for all Executive Branch  
Employees as authorized by the provisions of resolution #97-  
179, *The Executive Branch Wage/Salary Compensation  
Administration for FY 98 (Effective October 1, 1997).***

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council hereby approves the Executive Branch FY 98 Base  
Budget in the amount of \$15,437,516.67.**

**BE IT FURTHER RESOLVED that funds in the amount of \$15,437,516.67  
are hereby appropriated and authorized to be expended from  
sources of funding approved by this Council for support of the  
FY 1998 budgets of the Tohono O'odham Nation.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the  
18TH day of SEPTEMBER, 1997 at a meeting at which a quorum was present  
with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT,  
pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI  
of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
