

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Continue FY 1998 Funding for Arizona Long Term Care
Services (ALTCS) Account 14-1300; October 01, 1997 - March 31, 1998)**

RESOLUTION NO. 97-396

WHEREAS, the Tohono O'odham Department of Human Services under the Executive Office and the Legislative Branch of the Tohono O'odham Nation has had a long term interest in providing Long Term Care to its members; and

WHEREAS, the Tohono O'odham Nation has been providing ALTCS Case Management services since June 1996 and has been receiving reimbursement from the State of Arizona for these services: and

WHEREAS, the ALTCS Revenues are currently at \$76,568.57 and \$72,445.54 is needed to cover the salaries of four (4) ALTCS staff for six months.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:

- 1. That it hereby approves the budget utilizing ALTCS Revenues for salaries.**
- 2. That the remaining revenues of \$4,123.03 be kept for future expenses of the ALTCS Program.**
- 3. That the Tohono O'odham Nation's officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant,**

provided however, that any amendment affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
