RESOLUTION NO. 97-397

WHEREAS, the Tohono O'odham Nation is presently operating the FY 1997 contracts with the Indian Health Service under a three (3) year Master Contract effective from 1 October 1995 through 30 September 1998; and

WHEREAS, such Tribal operations have been successful and beneficial to the Tohono O'odham Nation and its members; and

WHEREAS, the Tohono O'odham Nation does desire to continue services as provided for in Tohono O'odham Legislative Council Resolution No. 97-332 which approved the Annual Funding Agreement (AFA) for FY 1998 for said programs:

- a) Management of Health Programs**
- b) Community Health Representative Program and the Community Counseling and Relations Services Programs**
- c) Tohono O'odham Psychological Services Programs**
- d) Alcohol and Substance Abuse Program**

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does authorize expenditures in accordance with attached budgets:

- a) Management of Health Programs \$ 226,511.00**
- b) Community Health Representative Program and the Community Counseling and Relations Services Programs \$1,526,247.00**


