

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 97 Agricultural Extension Program - Final Allocation)**

**RESOLUTION NO. 97-399**

**WHEREAS, the Tohono O'odham Nation is presently operating the Agricultural Extension Program under FY 1997 P.L. 93-638 contract with the Bureau of Indian Affairs; and**

**WHEREAS, such funds are available for obligation to reflect final funding for FY 1997; and**

**WHEREAS, an amendment has been submitted for review and approval by the Agricultural Extension Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the amendment to the Agricultural Extension Program contract and authorizes expenditures in accordance with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
