**WHEREAS, the JTPA/NEW program has brought forth a budget  
modification which includes the addition of two new line  
items 625.00 Student Stipends, and 626.00 Training &  
Allowances; and**

**WHEREAS, the budget modification decreases line item 650.00  
Training/Registration by \$120,341.00 and adds \$68,877.00 into  
line item 625.00 and \$51,464.00 into line item 626.00.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that it does hereby approve the JTPA/NEW program's  
Title IV DOL Budget Modification #1 for FY 1997.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the  
18TH, day of SEPTEMBER, 1997 at a meeting at which a quorum was present  
with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT,  
pursuant to the powers vested in the Council by Section 1(f) of Article VI of  
the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
