

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Addendum No. 1 to FY 97 Consultant Contract for  
Graciela Barajas)**

**RESOLUTION NO. 97-402**

**WHEREAS, the Tohono O'Odham Nation entered into a Consultant Contract for FY 97 with Graciela Barajas with a budget of \$40,000, comprised of \$30,000 for consultant fees and \$10,000 for expenses; and**

**WHEREAS, the consultant fees and expenses have exceeded the budgeted amount, and the Cultural Preservation Committee has recommended an increase in the budget of an additional \$7,000 to cover fees and expenses already incurred or to be incurred by September 30, 1997; and**

**WHEREAS, the needed additional funds are available within Account No. 01-1002-810 (Legislative Professional Services).**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council approves Addendum No. 1 to Professional Services Contract Between Graciela Barajas and the Tohono O'Odham Nation in the form attached hereto, providing for an increase of \$7,000 in the contract budget for a total contract amount of \$47,000, which additional funds are to be made payable from Account No. 01-1002-810 (Legislative Professional Services).**

**BE IT FINALLY RESOLVED that the Tohono O'Odham Legislative Council authorizes the Chairman of the Nation and the Chairman of the Legislative Council to sign the Addendum.**


