RESOLUTION NO. 97-403

WHEREAS, on Saturday, June 28, 1997, the Initiative (IN-01-97) known as the "O'odham Voice" was passed into law by a majority of the members of the Tohono O'odham Nation; and

WHEREAS, the Initiative appropriates and authorizes the expenditure of gaming revenues for a per capita cash distribution of \$2,000 for all enrolled members living as of the date of the Initiative's passage; and

WHEREAS, funds are required to provide for all general administrative costs associated with and required for implementation of the Initiative; and

WHEREAS, in accordance with Executive Order 97-001, the Enrollment Office will be charged with creating a system of tracking the membership of the Nation to provide accurate information to the Accounting Department for the purposes of accurate funds distribution; and

WHEREAS, in accordance with Executive Order 97-001, the Enrollment Office will require \$88,839.07 in order to cover the costs associated with providing an accurate assessment of the membership rolls.

NOW, THEREFORE, BE IT RESOLVED that the Enrollment Office's budget of \$88,839.07 is approved for the purposes set forth herein and that such funds be appropriated from gaming revenues.

BE IT FINALLY RESOLVED THAT any funds expended prior to the approval of the Enrollment Office's budget for the purposes of meeting the requirement of the Enrollment Office for implementing Initiative IN-01-97 shall be so replaced from funds appropriated herein.

BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the Investment Committee to transfer the amount of \$88,839.07 from the gaming investments into the General Account.

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
