

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Baboquivari District Fiscal Year 1998 Budget)**

RESOLUTION NO. 97-407

WHEREAS, the Baboquivari District Council has determined that in order for its administration and communities to function adequately, a budget needs to be established to meet their needs for Fiscal Year 1998; and

WHEREAS, on September 27, 1997 the Baboquivari District Council reviewed and approved their Fiscal Year 1998 Budget; and

WHEREAS, Baboquivari District has sufficient funds in their District Account to cover the total amount of Fiscal Year 1998.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed and approved the proposed budget for Baboquivari District in the amount of \$737,219.07.

BE IT FURTHER RESOLVED that the amount of \$737,219.07 will be transferred into the separate District Account established for Baboquivari District by the Accounting Department.

The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
