**WHEREAS, at a meeting of the Tohono O'odham Legislative Council the  
Hickiwan District's FY "98" Budget was entertained; and**

**WHEREAS, the Legislative Council did discuss the Hickiwan District FY  
"98" Budget; and**

**WHEREAS, the Legislative Council is aware of the Financial impact study  
that is being done and is also aware that a distribution will be  
forthcoming which will be placed in the Everen Securities  
Account for the Hickiwan District; and**

**WHEREAS, the Hickiwan District Council will have sufficient funds once  
the allocation is distributed to cover the FY "98" Budget in the  
amount of \$640,235.15.**

**NOW, THEREFORE, BE IT RESOLVED that the Legislative Council is aware that  
the Hickiwan District Council agrees to set aside funds in the  
amount of \$276,868.80 to pay for the Salaries and Fringe  
Benefits line items and \$4,459.35 to pay for Insurance on  
District vehicles which will be placed in the Bank of America  
Account to cover these costs in the amount of \$281,328.15.**

**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council  
does approve the FY "98" Budget for the Hickiwan District in  
the amount of \$640,235.15. The remaining balance of**

**\$358,907.00 will be set aside in the Everen Account and will be brought back for amendments to the FY "98" Budget.**
