**RESOLUTION NO. 97-411**

**WHEREAS, during the September 29, 1997 Special Session, the Legislative Council did review the FY-98 Budget presented by the Pisinemo District; and**

**WHEREAS, the Pisinemo District did receive from the Tohono O'odham Nation an amount of \$710,144.01 thru the Gaming Revenues and the Mining Royalties; and**

**WHEREAS, the Pisinemo District formulated a FY-98 Operating Budget of \$680,955.00, with the remaining amount of \$29,189.01 to be deposited in an interest bearing account of an approved banking institution; and**

**WHEREAS, the Pisinemo District did request the separation of District Funds from the Tohono O'odham Nation's Accounting Department for FY 98 with the exception of the following:**
