**NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'Odham Legislative Council hereby authorizes continued operation for San Lucy District pending completion for FY 1998 Budget.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,406.0 FOR; -0- AGAINST; -0- NOT VOTING; and 521.0 [12] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
