

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Continue San Xavier District Government
Operation Pending Approval of FY 98 Budget)**

RESOLUTION NO. 97-413

**WHEREAS, the San Xavier District Administration is unable to forward its
FY 98 approved budget to the Tohono O'odham Legislative
Council (TOLC) before the Legislature concludes its last
regular session for FY 97; and**

**WHEREAS, it is in the best interest of the San Xavier District (District) to
continue its fiscal operation pending the review and approval
of its FY 98 budget by the TOLC; and**

**WHEREAS, the District has sufficient funds in its treasury to cover all
expenditures during this interim period.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council does hereby authorize the San Xavier District to
continue to expend funds for its regular operation at the FY 97
level pending approval of the FY 1998 San Xavier District
budget.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
29TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present
with a vote of 1,406.0 FOR; -0- AGAINST; -0- NOT VOTING; and 521.0 [12]
ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3)
of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
