

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Schuk Toak District FY-97 Budget Extension)**

RESOLUTION NO. 97-414

WHEREAS, the Schuk Toak District Council by Resolution No. ST-09-28-97-01 did approve to extend and continue expending from their FY-97 Budget; and

WHEREAS, the Schuk Toak District does have sufficient funds in their FY-97 budget to carry them over until their FY-98 budget is in place; and

WHEREAS, the Schuk Toak District will have the budget prepared and presented to the Tohono O'odham Legislative Council during their November 1997 session; and

WHEREAS, the extension of the Schuk Toak District budget will be for a period until their FY-98 budget has been approved.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the Schuk Toak District FY-97 budget extension to continue expending from their FY-97 budget until their FY-98 budget is in place.

The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,595.0 FOR; -0- AGAINST; -0- NOT VOTING; and 332.0 [09] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
