**RESOLUTION NO. 97-418**

**WHEREAS, the Tohono O'odham Nation's programs and departments  
fiscal year ends at midnight, September 30, 1997; and**

**WHEREAS, the Tohono O'odham Nation funds the Chukut Kuk, Guvo  
Ranger programs and the Pisinemo Security with tribal  
dollars; and**

**WHEREAS, the Budget and Finance Committee is recommending that the  
Tohono O'odham Nation consolidate the programs to be the  
over-all Nation-wide Ranger Program.**

**NOW THEREFORE BE IT RESOLVED THAT THE Tohono O'odham Legislative  
Council supports the continuing operations of the Chukut  
Kuk, Gu Vo Ranger Programs and the Pisinemo Security until  
the October General Session when the Tohono O'odham Law  
Enforcement Department presents an over-all budget to this  
Council**

**The foregoing Resolution was passed by the Tohono O'odham Council on the  
29TH, day of SEPTEMBER, 1997 at a meeting at which a quorum was present  
with a vote of 1,591.0 FOR; -0- AGAINST; 190.0 NOT VOTING; and 146.0 [03]  
ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of  
Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
Tohono O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
