RESOLUTION NO. 97-421

WHEREAS, the Gu Achi District Council on September 19, 1997 did adopt and approve the FY-98 proposed budget in the amount of \$772,113.68; and

WHEREAS, the FY-98 proposed budget of Gu Achi District will be funded by the Gaming Revenues of the Tohono O'odham Nation; and

WHEREAS, the Gu Achi District Council is proposing that the Gaming Revenue monies in the amount of \$772,113.68 be deposited in #59078 with Paine Webber, Inc.; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the Gu Achi District FY-98 Budget and desires to invest with Paine Webber, Inc., hereby approves the same.


NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Gu Achi District FY-98 Budget to be expended in accordance with the attached budget.

The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,563.0 FOR; 137.5 AGAINST; 80.5 NOT VOTING; and 146.0 [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
