

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Lobbying Contract between the Tohono O'Odham Nation
and Ducheneaux, Taylor & Associates)**

RESOLUTION NO. 97-423

WHEREAS, the Tohono O'Odham Nation recognizes the need to obtain legislative and administrative advocacy services in regard to programs and services of the Federal government of the United States of America; and

WHEREAS, the firm of Ducheneaux, Taylor & Associates has continued to provide adequate services into Fiscal Year 1998 including; to advise the Nation regarding Federal initiatives; to act as liaison with the Federal Executive and Legislative Branches; to arrange meetings with Federal Officials; to provide specific reports on services provided directly to the Nation; and

WHEREAS, funds in the amount of \$60,000.00 plus \$10,000.00 have been appropriated in anticipated expenses by the Legislative Council of the Tohono O'Odham Nation for the purpose of obtaining these services in Fiscal Year 1998.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials to wit: the Chairman or any designated official are hereby authorized to negotiate and execute the contract provided in the amount of \$60,000.00 plus \$10,000.00 in anticipated expenses, and that any amendments affecting the funding levels of the contract shall be submitted for further prior approval by this Council.
