RESOLUTION NO. 97-424

**WHEREAS, the FY 1998 Legislative Branch Budget will end at midnight
September 30, 1997 and all spending authority granted under
Fiscal Year 1997 will end at that time; and**

**WHEREAS, the Legislative Branch has prepared and submitted for review
and approval their FY 1998 Budget; and**


**WHEREAS, on September 24, 1997 the Budget and Finance Committee did
review and approve the FY 1998 Legislative Branch Budget.**

**NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'Odham Legislative
Council hereby approves the FY 1998 Legislative Branch
Budget in the amount of 2,500,000.00**

**BE IT FURTHER RESOLVED that the funds in the amount of \$2,500,000.00 are
appropriated and authorized to be expended from sources of
funding approved by this Council for support of the FY 1998
budgets of the Tohono O'Odham Nation.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
29TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present
with a vote of 1,273.0 FOR; 508.0 AGAINST; -0- NOT VOTING; and 146.0 [04]
ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of
Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
