

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Water Resource Committee FY 1998 Budget)**

**RESOLUTION NO. 97-426**

**WHEREAS, the Legislative Council did allocate Water Trust Funds for the Water Commissioners for the purpose of paying cost for work performed on water activities for the Nation; and**

**WHEREAS, the Water Commission has been designated as the Water Resources Committee and is delegated the responsibility for water activities of the Nation; and**

**WHEREAS, the Legislative Council did request that the Water Resources Committee develop a budget and submit to the Legislative Council for consideration and adoption; and**

**NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'Odham Legislative Council does hereby approve the Water Resources Committee budget in the amount of \$116,626.00 effective October 1, 1997 to September 30, 1998 and that these funds be allocated from the Water Trust Fund as previously authorized for this committee.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,257.0 FOR; 524.0 AGAINST; -0- NOT VOTING; and 146.0 [04] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI and Article XVII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
