RESOLUTION NO. 97-427

WHEREAS, by Resolution No. 97-235 and 97-285 (Amendment), the TOLC appropriated \$100,00 to conduct a Population and Housing Survey; and

WHEREAS, the Survey is not completed to date due to unforeseen circumstances.

NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'Odham Legislative Council hereby approves the continuing resolution for the Population and Housing Survey Budget.

BEIT FURTHER RESOLVED that there is sufficient funding remaining within the budget.

The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,781.0 FOR; -0- AGAINST; -0- NOT VOTING; and 146.0 [04] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
