**RESOLUTION NO. 97-433**

**WHEREAS, by Resolution 96-520 the Tohono O'odham Legislative Council approved an Attorney Contract with the law firm of Gover, Stetson & Williams (the "Attorneys") to provide legal representation with respect to certain of the Nation's water matters; and**

**WHEREAS, the Attorney Contract expired on September 30, 1997; and**

**WHEREAS, continued representation regarding water matters is required to protect the Nation's interests; and**

**WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for fiscal year 1998 in the amount of \$10,000; and**

**WHEREAS, the operating budget of the Office of Attorney General for fiscal year 1998 includes sufficient funding for the Contract; and**

**WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of an Attorney Contract with the Attorneys on such terms.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

- 1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract with the law firm of Gover, Williams & Janov in the amount of \$10,000 for the fiscal year ending September 30, 1998 and in the form attached hereto.**


