4 **WHEREAS, by Resolution 96-521 the Tohono O'odham Legislative Council**  
5 **approved an Attorney Contract with the law firm of Quigley, Tang**  
6 **& Whitehill (the "Attorneys") to provide legal representation with**  
7 **respect to certain bankruptcy proceedings affecting the Nation's**  
8 **interests, and litigation and negotiations relating to the Central**  
9 **Arizona Project; and**

11 **WHEREAS, the Attorney Contract expired on September 30, 1997; and**

12 **WHEREAS, continued representation regarding these matters is required to**  
13 **protect the Nation's interests; and**

14 **WHEREAS, the Attorney General has recommended an extension of the**  
15 **Attorney Contract for fiscal year 1998 in the amount of \$50,000;**  
16 **and**

17 **WHEREAS, the operating budget of the Office of Attorney General for fiscal**  
18 **year 1998 includes sufficient funding for the Contract; and**

20 **WHEREAS, the Domestic Affairs Committee recommends approval by the**  
21 **Legislative Council of an Attorney Contract with the Attorneys on**  
22 **such terms.**

3. **The Chairman of the Nation is authorized and directed to execute the Attorney Contract.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 8TH day of OCTOBER, 1997 at a meeting at which a quorum was present with a vote of 1,695.0 FOR; 71.0 AGAINST; -0- NOT VOTING; and 161.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
