

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Law Firm of Raven & Kirschner)**

RESOLUTION NO. 97-435

WHEREAS, an Initiative, No. IN-01-97 (the "Initiative"), was approved by the voters of the Tohono O'odham Nation on June 28, 1997; and

WHEREAS, pursuant to Legislative Council Resolution 97-370, the Nation entered into an Attorney Contract with the law firm of Raven & Kirschner (the "Attorneys") to assist the Office of the Attorney General in assessing the tax implications for the Nation and its members associated with the implementation of the Initiative; and

WHEREAS, the Attorney Contract expired on September 30, 1997; and

WHEREAS, continued representation is necessary to protect the Nation's interests in these matters; and

WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for fiscal year 1998 in the amount of \$10,000; and

WHEREAS, the operating budget for the Office of Attorney General for Fiscal Year 1998 has sufficient funds for a Contract in such amount; and

WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of an Attorney Contract with the Attorneys on such terms.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract with the law firm of Raven &**

Kirschner, in the form attached hereto, in the amount of \$10,000 and for a term ending on September 30, 1998.

2. Funding for the Attorney Contract shall be provided under the Fiscal Year 1998 operating budget for the Office of Attorney General.

3. The Chairman of the Nation is authorized and directed to execute the Attorney Contract.

The foregoing Resolution was passed by the Tohono O'odham Council on the 8TH day of OCTOBER, 1997 at a meeting at which a quorum was present with a vote of 1,766.0 FOR; -0- AGAINST; -0- NOT VOTING; and 161.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
