WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for fiscal year 1998 in the amount of \$1,500; and

WHEREAS, the operating budget for the Office of Attorney General for fiscal year 1998 has sufficient funds for a Contract in such amount; and WHEREAS, the Domestic Affairs Committee recommends approval by the

Legislative Council of an Attorney Contract on such terms.

NOW, THEREFORE, BE IT RESOLVED THAT:

The Tohono O'odham Legislative Council hereby approves an 1. Attorney Contract with the Law Office of Russell C. Winston for fiscal year 1998, in the amount of \$1,500 and in the form attached hereto.
