**RESOLUTION NO. 97-441**

**WHEREAS, by Resolution No. 96-231 the Tohono O'odham Legislative Council  
approved the Fresnal Canyon Range Improvement Project; and**

**WHEREAS, the project is to be funded from the Baboquivari District's  
Economic Development Fund in the amount of \$35,785; and**


**WHEREAS, Fiscal Year 1997 ended September 30, 1997.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council approves the continuation of the Fresnal Canyon Range  
Improvement Project for Fiscal Year 1998.**

**BE IT FURTHER RESOLVED that funding will continue from the Baboquivari  
District Economic Development account in the amount of  
\$35,785 as previously budgeted.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the  
9TH day of OCTOBER, 1997 at a meeting at which a quorum was present with  
a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant  
to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).**
