**RESOLUTION NO. 97-443**

**WHEREAS, the Tohono O'odham Legislative Council did previously adopt calendar year budgets containing funded line items for leases and purchase of equipment under the P. L. 93-638 Grant Agreement No. 6-FG-32-00100; and**

**WHEREAS, the previously adopted budgets for calendar year 1997 did not contain a "Capital Equipment" line item; and**

**WHEREAS, the Water Projects Office wishes to make purchases of capital equipment under its calendar year 1997 budget.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby includes the "Capital Equipment" line item for purchases submitted on or after October 1, 1997, and approves expenditures as identified in this modification.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 9TH. day of OCTOBER, 1997 at a meeting at which a quorum was present with a vote of 1,807.0 FOR; 120.0 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
