**WHEREAS, the International Sonoran Desert Alliance ("ISDA") has scheduled a general members meeting for October 18, 1997 in Sonoyta to elect a Board of Directors to serve for the next three (3) years; and**

**WHEREAS, the Tohono O'odham Legislative Council has been invited by ISDA to nominate an individual to serve on the Board of Directors; and**

**WHEREAS, by Resolution No. 95-359 adopted on July 17, 1995 the Tohono O'odham Legislative Council appointed Councilmember Joseph Joaquin to serve on the ISDA Board of Directors for a period of one year, which term has expired; and**

**WHEREAS, the Cultural Preservation Committee of the Legislative Council has recommended that Councilmember Gloria Montana be nominated to serve on the ISDA Board of Directors for the next three (3) year term.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates Councilmember Gloria Montana to stand for election to the Board of Directors of the International Sonoran Desert Alliance at the October 18, 1997 members meeting, to serve for a period of three (3) years, representing the Tohono O'odham Legislative Council.**
