WHEREAS, the Tohono O'odham Nation is presently operating the Division of Community Health Services and Community Health Representatives under FY 1998 P.L. 93-638 Master Health Contract No. #249-96-001 with the Indian Health Services; and

WHEREAS, the Grants and Contracts Office has notified the Community Health Services/Representatives of Carry Over Funds available for obligation under FY 98 Master Health Contract; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the Divisions of Community Health Services/Representatives.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. It hereby approves the amendment and authorizes expenditures in accordance with the attached budget modification #1 submitted by Community Health Services/Representatives.**
