Counseling and Relations Services of Carry Over Funds available
for obligation under FY 98 Master Health Contract; and**

**WHEREAS, any amendments affecting the funding or funding levels of the
contract shall be submitted for review and approval by the
Tohono O'odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by
the Community Counseling and Relations Services.**

Council that:**


