

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Consultant Contract with Ricardo Tapia)**

RESOLUTION NO. 97-450

WHEREAS, the FY 98 Legislative Branch Budget was approved on September 30, 1997; and

WHEREAS, in October 1996 the President of the United States did sign into law the Native American Housing Assistance Self-Determination Act (NAHASDA) of 1996; and

WHEREAS, this Act (NAHASDA) will affect all tribes across the Nation including the Tohono O'odham Nation; and

WHEREAS, in order for the Tohono O'odham Nation to implement the NAHASDA Act, continued technical assistance is needed to assist the Legislative Housing Committee; and

WHEREAS, the Legislative Housing Committee has reviewed the consultant contract and recommends its approval.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby approves the consultant contract with Ricardo Tapia for \$30,000.**
- 2. The contract amount of \$30,000 shall be appropriated from the Professional Services line item of the FY 98 Legislative Branch Budget.**
- 3. The Contract is retroactive from 10/01/97 thru 03/31/98.**




