

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting a Revenue Allocation Plan for Per Capita Payments)**

4 **WHEREAS, on June 28, 1997 the voters for the Tohono O'odham Nation (the**
5 **"Nation") approved Initiative No. IN-01-97 (the "Initiative"), a**
6 **copy of which is attached; and**

7 **WHEREAS, the Initiative authorized (1) funding from "Gaming Revenues" for**
8 **a one-time per capita distribution of \$2,000 for each member of**
9 **the Nation enrolled on June 28, 1997; and (2) funding from**
10 **"available" Gaming Revenues for biennial per capita**
11 **distributions of \$2,000 to each member of the Nation enrolled on**
12 **the date which is two years after the date of the initial, one-time**
13 **per capita distribution, and every two years thereafter; and**

15 **WHEREAS, pursuant to the Indian Gaming Regulatory Act, 25 U.S.C.**
16 **§ 2710(b)(3), Gaming Revenues may not be used to make per**
17 **capita payments until a per capita distribution plan (the**
18 **"Revenue Allocation Plan") is approved by the Secretary of the**
19 **Department of the Interior; and**

21 **WHEREAS, Guidelines to Govern Review and Approval of Per Capita**
22 **Payments were issued on December 21, 1992 by the Assistant**
23 **Secretary for Indian Affairs (the "Guidelines"), a copy of which is**
24 **attached; and**

26 **WHEREAS, by Resolution 97-451, the Tohono O'odham Legislative Council**
27 **adopted an Initiative Funding and Implementation Plan (the**

WHEREAS, a Revenue Allocation Plan prepared pursuant to the Guidelines, and incorporating the FIP, has been presented to the Legislative Council for approval.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby adopts the Revenue Allocation Plan in the form attached hereto.**
- 2. The Chairman of the Nation is authorized and directed to submit the Revenue Allocation Plan to the Superintendent of the Papago Agency of the Bureau of Indian Affairs for transmittal to the Phoenix Area Office for approval.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 10TH day of OCTOBER, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(1), (2), & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
