

26 **Article II and Section 1(h) of Article VI of the Constitution of the Tohono**
27 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,**
28 **1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
