membership in the Tohono O'odham Nation, namely:**



Council on the 3RD. day of NOVEMBER, 1997 at a meeting at which a quorum  
was present with a vote of 1,766.0 FOR; 161.0 AGAINST; -0- NOT VOTING; and  
[07] ABSENT, pursuant to the powers vested in the Council by Article II,  
Section 3 and Article IV, Section 1(h) of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).**
