**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes Chairman Edward Manuel as the Tohono O'odham Nation's voting delegate and Legislative Chairman Dennis Ramon as alternate voting delegate to the 54<sup>th</sup> Annual National Congress of American Indians Convention.**

**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes payment of NCAI Membership dues in the amount of \$1,000 from the Legislative Branch Dues and Subscriptions line item.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 3<sup>RD</sup>. day of NOVEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,416.0 FOR; 322.0 AGAINST; -0- NOT VOTING; and 189.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
