RESOLUTION NO. 97-463

WHEREAS, the San Lucy District Council adopted Resolution SL 09-89-97, which permitted continuing operations of the District until such time that a comprehensive FY-98 budget is adopted by the San Lucy District Council and approved by the Tohono O'odham Legislative Council; and

WHEREAS, the Tohono O'odham Legislative Council Resolution 97-412 did approve for San Lucy District to continue operations under their FY 1997 Budget; and

WHEREAS, the District Council has prepared and approved their proposed FY 1998 District Budget in the amount of \$1,482,304.24 to cover anticipated cost and expenses from October 01, 1997 to September 30, 1998; and

WHEREAS, the San Lucy District has sufficient funds in the District's Gaming/Mining Revenue Account to provide for the proposed governmental operations in the amount of \$322,543.94 and P.L. 99-503 funds to provide additional administrative, support, and program operations contained in the FY-98 budget, in the amount of \$1,118,160.30; and

WHEREAS, funds in the amount of \$41,600.00 will be available from 93-638 Substance Abuse Contract to cover expenses related to the District's Drug and Alcohol Project.
