**WHEREAS, by Resolution 97-407 the Tohono O'odham Legislative Council
approved Baboquivari District FY-98 budget for \$737,219.07;**

and

**WHEREAS, any amendments affecting the funding level or change in the
purpose for which the funds were budgeted are required to be
submitted for review and approval by the Tohono O'odham
Legislative Council; and**

**WHEREAS, by District Resolution No. 97-B-52, the Baboquivari District
Council has approved amendments for Choulic Village for
\$5,042.60; and**

**WHEREAS, the total budget for Baboquivari District FY-98 is \$737,219.07;
and**

**WHEREAS, the District's revised budget total with the amendment is
\$742,261.67; and**

**WHEREAS, Baboquivari District has sufficient funds in its accounts for
said amendments.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council hereby approves the amendment to Baboquivari
District FY-98 Budget for \$5,042.60.**

**BE IT FURTHER RESOLVED that the amount of \$5,042.60 will be transferred
into a separate District account established for Baboquivari**
