

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Schuk Toak District FY 1998 Budget)**

**RESOLUTION NO. 97-469**

**WHEREAS, the Schuk Toak District Council convened in a special meeting on October 28, 1997 with a quorum present; and**

**WHEREAS, the Schuk Toak District Council did review the proposed budget and activities for FY-98; and**

**WHEREAS, the Schuk Toak District Council did approve the proposed budget as presented in the amount of \$695,279.53 on Resolution #ST-10-28-97-04; and**

**WHEREAS, the Budget will commence on October 01, 1997 and end on September 30,1998; and**

**WHEREAS, the Schuk Toak District will be utilizing Gaming Revenues and Mining Royalties that was made available to the Districts as approved by the Legislative Council in Resolution #97-385; and**

**WHEREAS, the Schuk Toak District Accounts are established with Everan Securities, for purpose of expenditures of the District's FY-98 Budget in the amount of \$695,279.53.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the FY-98 budget for Schuk Toak District in the amount of \$695,279.53 and that modifications to said budget can be made as necessary.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 6TH. day of NOVEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,669.0 FOR; -0- AGAINST; -0- NOT VOTING; and 258.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
