**RESOLUTION NO. 97-480**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 1ST. day of DECEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,476.0 FOR; -0- AGAINST; 451.0 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


