

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting the Initiative Budget of the Planning & Economic Development  
Department for Administrative Costs for Youth Centers in the Amount  
of \$276,542.83)**

**RESOLUTION NO. 97-484**

**WHEREAS, on Saturday, June 28, 1997, the Initiative (IN-01-97) known as the  
"O'odham Voice" was passed into law by a majority of the  
members of the Tohono O'odham Nation; and**

**WHEREAS, the Initiative appropriates and authorizes the expenditure of  
gaming revenues for the construction and indefinite operation of  
Youth Facilities justified in the Initiative's passage; and**

**WHEREAS, funds are required to provide for all general administrative costs  
associated with and required for implementation of the Initiative;  
and**

**WHEREAS, in accordance with Executive Order 97-003, the Planning and  
Economic Development Department will undertake an analysis  
and assessment of sites suitable for the construction of the Youth  
Centers, as well as the costs associated with construction and  
operations of identified Youth Facilities in the Districts of the  
Nation; and**

**WHEREAS, in accordance with Executive Order 97-003 the Planning and  
Economic Development Department will require \$276,542.83 in  
order to cover the costs associated with providing for the  
planning, site assessments, design and other activities necessary  
for the identification of these Youth Facilities; and**

**WHEREAS, the Tohono O'odham Legislative Council by passage of Resolution**

No. 97-478 authorized the Investment Committee to transfer the amount of \$1.8 million from the gaming investments into set-aside accounts for the Initiative Measures for the purpose of funding administrative costs.

**NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that the Planning and Economic Development Departments budget of \$276,542.83 is approved for Administrative Costs as set forth herein and that such funds be appropriated from the Initiative Administrative Costs set-aside account.

The foregoing Resolution was passed by the Tohono O'odham Council on the 2ND day of DECEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 OR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2), (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
