

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Vi-ikam Doag Industries, Inc., FY 1998 Budget and
Appropriating P.L. 99-503 funds in the Amount of \$600,000)**

RESOLUTION NO. 97-486

WHEREAS, Vi-ikam Doag Industries (VDI) is a duly Charter Non-Profit Corporation charged with the responsibility to Promote and Establish Business, Training Opportunities for the San Lucy District members; and

WHEREAS, Public Law 99-503, "The Gila Bend Indian Reservation Land Replacement Act", of 1986 provides financial resources to the San Lucy District for the purposes of land replacement, relocation, economic and community development; and

WHEREAS, the Vi-ikam Doag Board of Directors has prepared and submitted the FY 1998 budget in the amount of \$2,512,636.04 and requests appropriation of P.L. 99-503 funds in the amount of \$600,000 to be applied to the total budget; and

WHEREAS, the San Lucy District Council did review and approve the Vi-ikam Doag Industries FY 1998 budget by Resolution No. SL 11-102-97; and

WHEREAS, the Budget & Finance and Commerce Committees have reviewed and recommends approval of the Vi-ikam Doag Industries FY 1998 Budget.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Vi-ikam Doag Industries, Inc. FY 1998 budget in the amount of \$2,512,636.04 and hereby appropriates P.L. 99-503 funds in the amount of \$600,000 to be applied to the total budget.
