

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Gu-Vo District FY97-98 Budget)**

RESOLUTION NO. 97-489

WHEREAS, at a special meeting of the Gu-Vo District Governing Council held on November 21, 1997, the Council did resolve the following; and

WHEREAS, the Gu-Vo District Governing Council did review the proposed FY97-98 Budget submitted by the District Administration and its four communities, with the total amount of Seven Hundred Twenty-three Thousand Five Hundred Twenty-two and 50 Cents (\$723,522.50); and

WHEREAS, the Gaming Revenue and Mining Royalties were consolidated to cover the total amount of the said Administration FY97-98 Budget; and

WHEREAS, the following allocations are to be as follows:

Administration (Gaming & Mining)	\$483,522.50
Gu-Vo Community (Gaming)	\$ 60,000.00
Ali Chugk Community (Gaming)	\$ 60,000.00
Pia Oik Community (Gaming)	\$ 60,000.00
Kukatch Community (Gaming)	\$ 60,000.00.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports and approves the Gu-Vo District FY97-98 Budget in the amount of \$723,522.50

The foregoing Resolution was passed by the Tohono O'odham Council on the 4TH. day of DECEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,459.0 OR; -0- AGAINST; 322.0 NOT VOTING; and 146.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


