

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a budget amendment for South Komelic Village
of Baboquivari District)**

RESOLUTION NO. 97-490

WHEREAS, by Legislative Resolution No. 97-407 Baboquivari District has an approved budget of \$737,219.07; and

WHEREAS, Baboquivari District Council, by Resolution No. 97-B-55, has approved an amendment of \$21,100 to South Komelic Village budget; and

WHEREAS, any amendments affecting the funding level or change in the purpose for which the funds were budgeted are required to be submitted for review and approval by the Legislative Council; and

WHEREAS, Baboquivari District has sufficient funds to cover the amendment.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves the amendment of \$21,100 to Baboquivari District's budget, namely South Komelic Village, revising the total budget for Baboquivari District to \$758,319.07.

The foregoing Resolution was passed by the Tohono O'odham Council on the 4TH day of DECEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,781.0 OR; -0- AGAINST; -0- NOT VOTING; and 146.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
