(Appropriating the Sum of \$316,000. From the Set-Aside Authorized by  
Resolution No.97-475 and Authorizing the Chairman to Negotiate and  
Execute a Contract to Purchase One (1) Fire Truck)**

**RESOLUTION NO. 97-492**

**WHEREAS, the Tohono O'odham Legislative Council did through Resolution  
No. 97-475, establish a set-aside appropriation in the amount of  
\$1.8 million dollars for the purpose of acquiring fire suppression  
equipment.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

- 1. The sum of \$316,000. is appropriated from the \$1.8 million  
set-aside authorized by Resolution No. 97-475, for the  
purpose of acquiring fire suppression equipment.**
- 2. The Chairman of the Nation is authorized to negotiate and  
execute any and all contracts for purchase of such fire  
suppression equipment.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the  
5TH. day of DECEMBER, 1997 at a meeting at which a quorum was present with  
a vote of 1,927.0 OR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant  
to the powers vested in the Council by Section 1(d)(2) &(f) of Article VI of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).**
