BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that an additional amount of \$58,680.00 be appropriated to satisfy tax withholding obligations.

BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council does hereby approve and appropriate a total amount of \$547,680.00 from the General Account to provide for Christmas Bonus payments.

BE IT FINALLY RESOLVED that any expenditure from the General Account for the Christmas Bonus shall be replenished from the IC Accounts.

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 5TH day of DECEMBER, 1997 at a meeting at which a quorum was present, and by a vote of 633.5 FOR; 1,132.5 AGAINST; -0- NOT VOTING; and 161.0 [04] ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'odham Nation.
