RESOLUTION NO. 97-499

**WHEREAS, the Tohono O'odham Nation is presently operating the FY1997
Grant with the Title IV-B, Subpart 2 of the Social Security Act - five
(5) year plan; and**

**WHEREAS, such tribal operations have been successful and beneficial to the
Tohono O'odham Nation and its members; and**

**WHEREAS, the Title IV-B, Subpart 2 of the Social Security Act funds has
allocated additional funds to the Tohono O'odham Nation in the
amount of \$626.00 for FY1997, budget period 10/01/96 - 09/30/98.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that:**

**1. The Tohono O'odham Legislative Council authorizes the
expenditures of these funds according to the attached budget
for the following program:**

A. Family Preservation and Support Services

**2. That the Tohono O'odham Nation, to wit, the Chairman and
any designated Official are hereby authorized to negotiate
and execute the grant.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
5TH day of DECEMBER, 1997 at a meeting at which a quorum was present with
a vote of 1,781.0 OR; -0- AGAINST; -0- NOT VOTING; and 146.0 [05] ABSENT,
pursuant to the powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).**


