RESOLUTION NO. 97-500

**WHEREAS, the Tohono O'odham Nation is presently operating the P.L. 93-638
contract with the Bureau of Indian Affairs under a three (3) year
Master contract with FY98 being the second year; and**

**WHEREAS, such tribal operations have been successful and beneficial to the
Tohono O'odham Nation and its members; and**

**WHEREAS, the Bureau of Indian Affairs has allocated additional monies for
Welfare Assistance Grant Funds to the Tohono O'odham Nation in
the amount of \$447,000.00 for FY98. Funds were made available at
the end of FY97 and are identified as savings to be expended in
FY98.**

NOW, THEREFORE, BE IT RESOLVED:

**1. That the Tohono O'odham Legislative Council authorizes the
expenditures of these funds according to the attached budget
modifications for the following programs:**

- A. Family Assistance/Child Welfare**
- B. Adult Care Group Home**
- C. Children's Home Program**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
5TH. day of DECEMBER, 1997 at a meeting at which a quorum was present with
a vote of 1,781.0 OR; -0- AGAINST; -0- NOT VOTING; and 146.0 [04] ABSENT,
pursuant to the powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).**


