(Tohono O'odham Department of Human Services - Management of Health
Fiscal Year 1998 Base Budget Modification No. 1)**

RESOLUTION NO. 97-501

**WHEREAS, the Tohono O'odham Nation is presently operating the FY 1998
contracts with the Indian Health Services; and**

**WHEREAS, such tribal operations have been successful and beneficial to the
Tohono O'odham Nation and its people; and**

**WHEREAS, the budget modification is necessary to address program needs
and services; and**

**WHEREAS, the Department of Human Services desires to utilize the
remaining amount of \$33,653.00 of the Management of Health
contract carryover funds to add a professional services line item.;**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it approves the 1998 Management of Health Budget
Modification No. 1 as reflected in the attached budget.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
5TH day of DECEMBER, 1997 at a meeting at which a quorum was present with
a vote of 1,927.0 OR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant
to the powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).**
