RESOLUTION NO. 97-504

WHEREAS, the Tohono O'odham Nation is presently operating the Food Distribution Program under an FY 1998 Grant with the United States Department of Agriculture; and

WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the Food Distribution Program.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. It hereby approves the amendment and authorizes expenditures in accordance with the attached budget modification number two submitted by the Food Distribution Program.**
- 2. The Tohono O'odham Nation's officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, providing however, that any amendment affecting the funding or funding levels of this grant shall be submitted for further prior approval by this Council.**
